**Legislative, Financial and Health News (summarized from FEDWeek & GEMS Bulletins and NARFE Legislative Hotlines):**

**Congress & the Administration:** In the first week of November the House Oversight & Government Reform Committee passed a bill (HR 3029) that would reduce the federal workforce through attrition by up to 10% by 2015. The measure calls for hiring only one or two federal employee or contract employee for every three workers who retire or leave their job. There are about two million federal employees and 10.5 million contractor employees. There would be exceptions for national security or events which threaten public health or

safety. Federal employee groups and manager associations criticized the measure, saying it fails to consider all negative impacts of the legislation.

Other bills up for approval that week were HR 665 and HR 1734 to expedite the disposal of excess government buildings and other property, and a plan to strengthen protections for federal whistle-blowers.

Congress came back from its Thanksgiving recess planning to work at most three weeks more, with many budget-related issues unsolved. Regular appropriations for the current fiscal year have been enacted for only a handful of departments and agencies (Agriculture, Justice, Commerce, Transportation and HUD). Temporary funding for the rest expires December 16. Leaders are leading toward, as usual, one large wrap-up bill to extend through the remainder of the fiscal year. The super-committee's failure eased prospects of immediate changes in law which affect benefits and job levels, but only until January, 2013. But there may be some deals made in the upcoming year which we will have to watch out for.

Also pending is the size of the required Social Security payroll deduction from FERS and hybrid CSRS-Offset employees for 2012. Typically, it is 6.2%, but under a stimulus provision it is only 4.2% until the end of December.

**TSP funds:** The stock-oriented funds broke a five-month losing streak in October by posting large gains, led by the small company S-fund's 14.09%, followed by the large-company C-fund's 10.9% and the international I-fund up 9.48%. Over the last year, the S and C funds are up 7.44% and 8.06% respectively, while the I-fund was down 5.04%. The bond F-fund gained 0.11% and the securities G-fund gained 0.14%, with 12-month gains of 5.07% and 2.54% respectively. The October and 12-month returns for the lifecycle L-funds are: income, 2.31 & 3.48%; 2020, 6.18 & 4.24%; 2030, 7.68 & 4.48%; 2040, 8.83 & 4.57%; and the 2050 fund launched in February gained 9.92% in October.

The IRS announced the investment limit on tax-favored retirement savings such as the TSP (and others) will rise to \$17000 in 2012, up from the \$16,500 maximum since 2009. The separate limit on "catch-up" contributions will remain at \$5,500. The TSP also plans to start a "Roth" option next year in which investments are made with after-tax money, with withdrawals being tax-free.
