Legislative, Financial and Health News (summarized from FEDWeek Bulletins and NARFE Legislative Hotlines):

COLAs, CPI, Pay Raise: The next COLA for retired and disabled federal workers will be 3.3%. Social Security, civil service, foreign service and military retirees will receive the adjustment in their January checks. FERS annuitants age 62 and over receive the full amount on the Social Security portion, but only 2.3% on the FERS annuity add on.

The Labor Department reported October's CPI-W with a decrease of 0.7% from September. October's index is down 1.1% from the 2006 third-quarter base index. Due to possible inactivity from the lame duck Congress, the next pay raise may not get enacted until next year, so a temporary COLA may go into effect, probably a little over 2%. All bets are off about the final number after January, though.

Congress: The current continuing resolution allowing the government to spend money expires on December 5. The Senate will meet the week after Thanksgiving to attempt to pass some of the remaining nine appropriation measures already passed by the House.

There are five House races still undecided as of November 17, two of which need special elections in December to decide, so the final party makeup of the House is still not finalized, but both houses will be controlled by Democrats.

Health: OPM has sent out guidance on some significant changes in the FEHB program for the upcoming year, but no plans in our local area seem to be affected much. Inflation in health care has seemed to have moderated, so average premium will only raise about 1.8% (your plan may vary). There are several special enrollment provisions important to retirees who may consider joining the new Federal Dental and Vision Insurance Program (FEDVIP) during the current Open Season which runs through December 11. Annuitants are eligible if retired on an immediate annuity under most government retirement programs, including disability, and whether or not they are eligible for the standard FEHB system. Those who retire on a deferred annuity are NOT eligible to enroll or con-

tinue their enrollment into retirement once separated. Also, in the future, if a retiree drops FEDVIP enrollment one year, they can rejoin in another year (unlike FEHB) since it is a separate system. Contact OPM for more details. Also, enrollment MUST be done by phone or online using the new "Benefeds" online portal (www.benefeds.com). Without access to a computer, retirees may call 877-888-3337 (TTY: 877-889-5680) to enroll. Paper enrollment forms will only be available to those unable to call during normal business hours, and must be gotten through their agency, which will then request it from OPM. Enrollment cannot be done through the FEHB form (SF 2809) or through an agency self-service system; but those sites may provide a link to the Benefeds site. Also beware: Many insurance companies are sending out flyers in the mail or e-mail about their 'new' vision and dental plans, but are NOT authorized members of the FEDVIP system. You must enroll through the Benefeds system and NOT directly with any carrier if you wish to enroll in FEDVIP. The official companies are: for Dental: Aetna, GEHA, MetLife, United Concordia, Triple-S, GHI and CompBenefits; for Vision: Blue Cross/Blue Shield, Spectera and VSP. The first coverage will be effective as of December 31.

TSP Funds: No new TSP offerings were recommended by the consultant studying current and future offerings from the TSP. It was concluded current options are about comparable to private sector 401(k) plans, and employees should not be exposed to the risks associated to smaller market sectors such as real estate investment trusts (REITs), for example. The plan currently offers three stock oriented funds, one bond fund, one government securities fund and five lifecycle funds which mix investments in those funds.

All three stock-oriented funds posted substantial gains during October; the small stock (S) fund increased 4.99%, the International stock (I) fund up 3.87% and the large stock (C) fund up 3.27%. Those three have gained 16.93, 27.54 and 16.32 percent, respectively, over the last 12 months. The bond (F) fund was up 0.73%, the government securities (G) fund up 0.43% for 12-month gains of 5.22% and 4.97% respectively. The Lifecycle fund returns for October and their 12-month returns were: 2040, 3.28 (17.41); 2030, 2.94 (15.91); 2020, 2.51 (14.36); 2010, 1.79 (11.71); and Income, 1.04 (7.8%).

Public Warned about E-mail Scam

Jo Anne Barnhart, Commissioner of Social Security, and Patrick O'Carroll, Jr., Inspector General of Social Security, issued a warning today about a new email scam that has surfaced recently.

The Agency has received several reports of an email message being circulated with the subject "Cost-of-Living for 2007 update" and purporting to be from the Social Security Administration. The message provides information about the 3.3 percent benefit increase for 2007 and contains the following "NOTE: We now need you to update your personal information. If this is not completed by November 11, 2006, we will be forced to suspend your account indefinitely." The reader is then directed to a website designed to look like Social Security's Internet website.

"I am outraged that someone would target an unsuspecting public in this manner," said Commissioner Barnhart. "I have asked the Inspector General to use all the resources at his command to find and prosecute whoever is perpetrating this fraud."

Once directed to the phony website, the individual is asked to register for a password and to confirm their identity by providing personal information such as the individual's Social Security number, bank account information and credit card information.

Inspector General O'Carroll recommends people always take precautions when giving out personal information. "You should never provide your Social Security number or other personal information over the Internet or by telephone unless you are extremely confident of the source to whom you are providing the information," O'Carroll said.
