



January Meeting: About 8 members played 6 Bingo games before lunch (about 11:15am to noon), winning \$11.80 among them. (Members contributed 5¢ per card for regular games and 10¢ per card for the blackout game; many played multiple cards.) \$10 of the winnings were contributed to the Alzheimer's fund. Prayer was offered by Birdie Allen, then 12 members attended the pot luck luncheon.

The business meeting started at 1:09 with the usual prayer and flag salute. Minutes were read for the November meeting by secretary Wanda Collins, and they were approved as read. Unofficial minutes of activities at the December meeting were also read. Correspondence were passed around. The treasury report was read for the last two meetings by treasurer Byron Nichols and accepted for audit. Bills were ratified, both those paid prior to the meeting and those awaiting payment, including postage for the past two months, the bulk mail permit, a half-page ad in the upcoming convention program and per-capita dues to the KS Federation for 2009.

The Alzheimer's ticket drawing was for #480113, Byron Nichols, for \$8.25. The attendance drawing was #8, Kathy Zunick, for \$5. Both were contributed to the Alzheimer's fund. A total of \$23.25 was collected for Alzheimer's this month (Bingo, tickets and attendance prize from the chapter). So far this year the chapter has sent **\$23.25** to the Kansas Federation Alzheimer's coordinator (or, about \$0.09 per official member).

The meeting was adjourned at 1:39.

Legislative, Financial and Health News (summarized from FEDWeek Bulletins and NARFE Legislative Hotlines):

CPI/COLA News: The CPI-W declined for the fourth consecutive month at 1.2% for December. The index is now 5% below the 2008 3rd quarter average index that the next COLA is based upon. Current law states benefits **won't** be reduced when the CPI is lower than the prior year's average. December's data completes the measurement year for FECA benefits. That index is also 5% lower than calendar year 2007 numbers, so there will be no COLA for FECA benefits.

Congress: NARFE President Margaret Baptiste salutes those members who have already contacted their Senators and Representatives to urge them to include Premium Conversion in any economic stimulus package as an amendment; and encourages all others who have not to do so. A groundswell of NARFE communications sent ASAP could provide civilian and military retirees an economic boost that they could inject into the economy. When writing, calling or e-mailing your delegation, ask them to include the federal civilian/military Premium Conversion legislation into the stimulus package, which was introduced in the last Congress as H.R.1110 and S.773.

On December 23, 2008, President Bush signed into law the "Worker, Retiree and Employer Recovery Act of 2008" (P.L.110-458), which allows individuals to suspend the required minimum distribution payments for 2009 from IRAs and defined-contribution plans (401(k)s). TSP participants may also take advantage of this, although some on monthly withdrawals may not be able to completely stop all withdrawals. The TSP has issued formal guidelines on their site, www.tsp.gov. They will also mail a special notice to affected individuals by the end of January. The Treasury Department may not

as yet have issued full regulations concerning the new law, so individuals may have to contact their individual retirement plans.

On January 7, Rep. Howard Berman (D-CA) again introduced legislation to entirely repeal both the Social Security Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP). The House bill number is H.R.235. Members are encouraged to urge their representative to cosponsor this bill and get it through the Ways and Means subcommittees, the usual roadblocks. Recent data indicates about 465,000 Social Security beneficiaries are affected by the GPO, of whom 77% are women and 43% are widowed, and 75% have lost their entire Social Security spousal benefit. The data also shows roughly 972,000 Social Security beneficiaries are affected by the WEP. NARFE President Baptiste has said, "The GPO and WEP arbitrarily eradicate the earned Social Security benefits of far too many public sector retirees. There is absolutely no legitimate reason for one segment of seniors being denied their Social Security benefits for which full Social Security taxes were paid."

TSP Funds: The stock-index oriented TSP funds posted by far the worst year in the program's two-decade history in 2008, with the International stock (I) fund losing 42.43%, the small company (S) fund dropping 38.32% and the large company (C) fund down 36.99%. The bond (F) fund gained 5.45% for the year and the government securities (G) fund gained 3.75%. The 2008 returns for the lifecycle funds are: Income, -5.09%; 2010, -10.53%; 2020, -22.77%; 2030, -27.5%; and 2040, -31.53%.
