PRESIDENT JOSEPH A BEAUDOIN HAS ISSUED ANOTHER ALERT "TO ALL NARFE MEMBERS". The Message Is Directed to NARFE Members, Spouses, All Federal Employees, including Postal Employee, Spouses and Federal Retirees. "Mark Wednesday February 15<sup>th</sup> on your Calendar. "A House-Senate Conference Committee facing a February 29th deadline will soon begin negotiations on "Extending the payroll tax Holiday" "The House passed position asks current and future federal employees to bear A third of the cost of extension through a further pay freeze and increased retirement contribution totaling \$64.5 "billion" over(10) ten years."

NARFE AND THE ENTIRE FEDERAL POSTAL COALITION ARE FIGHTING BACK. "Tell your Congressman the proposal is unfair. Save the date of Wednesday, February 15 and share this step by step plan with all NARFE chapter members, through newsletters and other communication channels.. "Any plan that pays for 1/3 of the payroll tax cut by taking money out of the pockets of fewer than 2% of America's middle class is unacceptable, unfair, & certainly not shared sacrifice."

1. Call the Capitol Switchboard using NARFE's toll free number, 1-866-220-0044. Ask the operator to connect you to your representative's and/or Senator's office.
2. Tell the staff person who answers the telephone where you live, so they know you are a constituent then say--"I am a retired/active federal employee, member of NARFE or Survivor Annuitant. Tel<sup>l</sup> the staff person a little about your work, or other appropriate comments.
3. Senators/Representatives represent thousands of federal workers and retirees and their survivors. "Any plan that pays for 1/3 of the payroll tax cut by taking money out of the pockets of fewer than 2% percent of America's middle class is unacceptable, unfair, & "not" a shared sacrifice..
5. "Federal workers, retirees and survivors have already did their part, by saving the federal government \$50 billion over two years. Making \$65 billion in further cuts to pay earned health and retirement benefits, or making changes to cost of living adjustments will unfairly single out those who protected our nation, including many now on a fixed incomes like "you". - - - - -

Is it because the current federal workforce is bloated? Hardly, in the last 20 years we have lost 200,000 federal employees. In fact our nation employs virtually the same number of federal workers today as we did under President Truman even though our population has nearly doubled.

Is it because someone in the private sector can do these jobs for less money? Not according to a new study by the "Project on Government Oversight," discovered the U. S. government already pays billions more annually in taxpayer dollars to hire contractors than it would to hire federal employees to perform the same services.(Limiting federal jobs will lead to paying more contractors and cost taxpayer more money).

"If Congress thinks the federal government should reduce spending by discontinuing a specific program or policy, it should vote to discontinue the program or policy. But it must not arbitrarily reduce the entire workforce and call it a solution. This approach threatens the services and security that our federal workers provides Americans in every state. We must not allow this irresponsible bill to progress any further than it already has to become law.

During a hurricane, National Weather Service would never send out a memo telling 1 in 10 Meteorologists to go home. If America's spinach supply is contaminated; US Dept of Agriculture. would not ask 1 in 10 employees to turn in their badges. Tell one in 10 Federal Security Officers Scheduled for duty to take the night off. Border Patrol agents, send one in 10 of them home and tell them they can sit this one out. Why is the Chairman proposing that our nation arbitrarily lose 1 in 10 of our federal workers who perform these vital jobs every day? --(Why did a majority of the members of the House Committee on Oversight and Government Reform support his plan that singles out federal workers in the collective struggle to lower the national debt??
