ALZHEIMER: Mary Ellen Geist an Award-Winning Journalist spoke at the NARFE National
Convention, how Alzheimer Disease changed her career. She left her radio job and returned home
to take care of her father, Woody Geist who had Alzheimer. During her caring for him she noted the
role music played in her ability to communicate with him when nothing else worked. She said there
is research being done now to try to ascertain the role that music can play in the lives of Alzheimer's
victims and their caregivers. The story (book) she has written is, "MEASURE OF THE HEART": a
father's Alzheimer, a daughter's return. She said, the return home to care for him was the best thing
she had ever done. He died March 10, 2010.

NARFE Members have raised \$8,787,824 to date, with a goal of \$9 million by years end. All
monies collected by NARFE goes for research. At the Convention in Grand Rapids Michigan last
month, Four new Research Projects were approved to fund for a total of \$560,000. Forty-Nine (49)
projects have been approved to date for funding.. This year marks 25 years that NARFE has worked
with the Alzheimer Association. Before NARFE joined the Alzheimer Assn. very few funds were
available for research. "Kansas is one of the leading states in making contributions to Alzheimer."

NARFE DUES INCREASE: Delegates at the NARFE National Convention in Grand Rapids, Michigan last month voted to increase membership dues affective January 1, 2011. Dues will increase from \$33.00 plus chapter dues per year to \$40.00 plus chapter dues per year. There has been no increase in NARFE dues since 2002. Cost of Living Adjustments for members increased, 2.1% in 2003, 2.7% in 2004; 4.1% in 2005; 3.3% in 2006; 2.3% in 2007 and 5.3% in 2008, with no increase in 2009 and none anticipated for 2010. Members on Dues Withholding will have an increase in dues rate also; however they will continue to receive a discount for participating in "Dues Withholding" thus sharing the saving made by payment of dues by this method. When on "Dues Withholding" Dues are paid monthly, thus a saving to the member and to NARFE. No payment of dues for the full year in advance..

PAPERLESS COMMUNICATIONS: Starting in January 2011, NARFE will initiate a paperless communication, which means all chapter reports will be secured from the NARFE web site by the chapter each month.. This is being done as a cost saving factor. With over 1200 Chapter Membership monthly reports mailed each month, reporting membership changes to chapters, thus a Cost saving plus "going green".

Efforts through the years since the benefit(State Income Tax exclusion) was passed have been made to "lift" federal retirees "ONLY" out of the Exclusion, with the state income tax benefit. Other retired employee groups with the benefit are KS Public Employee Retirement System (KPERS): KS. Police & Firemen's Retirement System; KS Teachers Retirement; KS Highway Patrol; KS Justices & Judges Retirement; Washburn University, Railroad Retirement; and several other categories. The ENTIRE benefit could be under fire for "ALL Organizations". "That should be all the incentive we need to work for a stronger NARFE in KANSAS and in Washington D.C.
