**From Louis Bornman, 2<sup>nd</sup> Vice President and Legislative Chair**

For several months now I have been trying to put together a coalition of Kansas and Missouri NARFE Chapters who will donate money toward running several radio ads in the local Kansas City area radio market for two purposes: 1. to generate some positive feedback to area congressional members from area employees and the public on federal employee and retiree pay and benefits and; 2. to let local and surrounding county federal employees and retirees know about NARFE and try to recruit new members. Of the some 52,000 plus federal employees and retirees in the Kansas City metropolitan area and surrounding counties I figure only about 10 percent know about NARFE and/or are members. If we could reach just another 10 percent of those people we have the opportunity to double the membership of our area chapters. I have been able to get commitments from area chapters for \$700 and have been approved by National HQ Public Relations for \$700 in matching funds. I have contacted KMBZ News Radio 980AM/98.1FM and hope to be able to run the ads starting the week of November 14th. This timing is critical as the Supercommittee on the debt is scheduled to release their debt reduction recommendations by November 23rd. We need to have a response that supports maintaining federal employee and retiree pay and benefits. Please listen for the ads in the afternoon between 4PM and 6PM. ALSO, you need to take action NOW and call, write, and email our Congressman and both Senators through the NARFE "Protect America's Heartbeat" program and let them know to not support cuts to federal employee and retiree pay and benefits! Make your voices heard!

There is no doubt that we are facing a "turbulent" political climate based on congressional committee recommendations submitted to the "Supercommittee" of 12 individuals who have been charged to present recommendations to cut the national deficit by Thanksgiving. Never in our history have 12 people had so much power to affect our lives.

On October 14th, NARFE President Joe Beaudoin released the following statement: "We are very concerned about the reckless plans submitted to the supercommittee this week that will impact the future of our nation's federal workforce." The plans referred to by President Beaudoin are those contained in recommendation letters from both the House Oversight and Government Reform Committee chaired by Rep. Darrell Issa, and the Senate's Homeland Security and Governmental Affairs Committee chaired by Senator Joseph Lieberman and Ranking Member Susan Collins. Though the recommendations from the Homeland Security Committee are not as severe, the recommendations in both of these letters single out hardworking federal employees. I encourage all members to read the complete text of all the congressional committee recommendations found on the NARFE website, [www.narfe.org](http://www.narfe.org).

The annual election of chapter officers will take place at the November Chapter meeting. All existing officers have agreed to submit their names to run for office once again. For the two board of director positions, Pat Daly and Frank McGough have agreed to be candidates. We are grateful that they are willing to be candidates. ## Alzheimer's News - Eddie Acosta, 1st VP

I would like to remind you that November is Alzheimer's Awareness Month and we have a speaker, Kelly Jones, from the Alzheimer's Association who will be speaking at our next chapter meeting.

Our program for the January meeting will be on understanding the new health care law, the Affordable Care Act. The speaker will be Amy Smoucha. Most recently, Amy spoke at the St. Louis' chapter meeting.

As an additional way of raising funds for Alzheimer's research, one of our members has generously donated two tickets/vouchers for the American Heartland Theater in Crown Center for a single event of your choice, during the 2012 season beginning in January. The tickets cannot be used on Friday or Saturday evenings without an additional charge. ### Service Officer, Elizabeth Bornman

Remember Open Season starts 14 November to 12 December 2011. Your benefits cover your children up to 26 years of age. However, if you have the Federal Employees Dental and Vision Insurance programs it only covers children to age 22. Read your policies. Your FEHB plan may already cover what you need in vision and dental coverage.

Hopefully, we will receive the COLA of 3.6% for CSRS and 2.6% for FERS retirees. You never know what Congress will do these days to your entitlements. It's important that your spouse assume your membership when you pass away. The entitlements are still important to fight for even after your death. My position as service officer is to provide assistance to you as the member and to your spouse after your death. Remember to get a sufficient number of original death certificates. Everyone these days seems to want an original copy. If you are getting Social Security you have to ask for the death benefit of \$250. It is not automatic.
