**October Meeting** - Met at the Beagle United Methodist Church with 32 attending including Gale Beck and his wife. Gale gave a report on the National Convention held in Louisville, KY. Our State President is now Robert Cranmer. The first one resigned because of health problems and the second one because of family health problems. Kansas was represented by 20 attending. Had a memorial service. In two years Region V has lost 1,667 members. Have raised \$7,590,279 for Alzheimer's. Have allocated \$919,000 for five more research projects. New goal is \$9 million by end of century. Of the 340,000 NARFE members only 22,000 have entered their email address in NARFE headquarters personnel file. Some proposals - give all spouses a free membership; reinstate \$28 membership dues; one dues structure; provide every small chapter a free NARFE banner; serve NARFE members electronically. NARFE cannot eliminate these, they have to go to the committee. Adopted proposal to modify Honorary Membership Program. Current ones not affected. As they reach 85 years of age and 20 years of membership will receive a pin and special identification card and will continue to pay dues. Selected Grand Rapids, Michigan, as meeting site in 2010 and the Nugget in Reno, Nevada, in 2012. Approved proposal to allow NARFE National Executive Board to select future convention site instead of vote by delegates at convention. NARFE legislative program approved for next two years. Voted to equalize salaries for National Secretary and National Treasurer. Apply for scholarships by region and encourage high school students to apply. Premium Conversion is very costly and will cost over \$80 billion over a 10-year period. Recommended telephone trees be established within the chapter. Voted NARFE Headquarters pursue allowing active federal employees to use dues withholding. It is likely in 2009 Congress could start working on a premium conversion alternative that would extend the health care tax exclusion. We have \$478.18 in our checking account and \$809.05 in savings.
