**May 13 Meeting** - There were 24 in attendance including one guest. The Treasurer reported \$395.98 in checking and \$807.24 in savings. The State Convention was held in Hutchinson April 27-29. All chapters were represented and a total of 204 attended which included seven from this chapter. New officers were elected and there were two guest speakers - Richard Thissen, National Region V Vice President, who addressed the need for recruitment, health care coverage, honorary memberships and the ongoing defense of annuitants benefits, and Chuck Timanus, National Officer of Public Relations, who talked about recruitment and attempts to get NARFE information out in forms of advertising. All four representatives now support Premium Conversion and GPO/WEP. NARFE will testify in support of legislation to facilitate temporary employment of annuitants. Currently re-employment occurs with their pay being offset by the amount of the previously earned annuity. New legislation would allow them to earn full pay plus their annuity. There is a large untapped group of possible members - current employees. Need to make present and future retirees aware that the benefits we have are not secure and can be taken away. Also, lack of knowledge of health care changes, state tax exemption, ongoing COLA, and the effects of GPO/WEP. Need to recruit and inform members and potential members of the benefits of NARFE. Suggested doing away with life memberships, honorary memberships, etc. It is projected that in five years there will be 40,000 honorary members. Lost 34,000 members last year due to non-renewal. Teresa Staley attended the Service Officer meeting at the convention and has agreed to assume the duties of Service Officer for our chapter. Increasing per capita dues by 50 cents was voted down. PAC contributions should be kept as a high priority as this money will help secure support for our issues in the political arena. This chapter contributed \$275 this year. Kansas led Region V with \$23,573 contributions to Alzheimer's last year. The 2008 goal is \$5.00 per member. The live auction and silent auction at the convention amounted to \$4,035. A memorial service was held for the 208 members who passed away this year - included our two members, John Jasper and Ferne Brand.

**Membership** - There is strength in numbers and only through continued membership gains can we keep up with the loss due to death and members being dropped for non-renewal. We need to promote dues withholding to protect long-term stability.
