**SECRETARY'S REPORT by Lannie Pender:** Acting President Ray Thompson, National Association of Active and Retired Federal Employees (NARFE) called the January 12, 2012, Chapter #383 meeting to order at 11:30, 4H/Senior Citizens Center. Invocation was led by Chaplain Maxine Kroeplin, followed by the Pledge of Allegiance.

Acting President Thompson requested that all the Birthday and Anniversary members to please stand; he then extended birthday and anniversary wishes to those celebrating in the month of January. Clarice Longhofer will be added to the January birthdays. A motion was made by Maxine Kroeplin and seconded by June Buckles to approve the December 2011 minutes. Bob Norcross motioned that the Treasurer's report be approved and filed for January. Both motions were passed by attending members vote. Acting President Thompson read a paper on the creation of the "Pledge of Allegiance." ### **To chapter Presidents: IMPORTANT – A MUST READ – STATE TAX EXEMPTIONS**

Given that there is much discussion lately about possible proposed changes to state tax exemptions in Kansas, it was felt that an email to clarify what is going on at state legislature would be useful. Ron Richey as well as Jim Miller of the Topeka Chapter is attending the legislative sessions to keep on top of any potential proposals that could affect our annuities. Judy Etter, Area 1A Vice President from the Amelia Earhart chapter has also been contacting her congressional district staff as well. Latest email from Jim Miller, Topeka Chapter:  
"Hello Louise, I just returned from the State House / Docking Building, where the House Tax Committee discussed HR 2480, the Governor's Tax Bill, or I could say, what's left of it. Every Democrat and more than several key Republicans believe his tax bill should have been Dead On Arrival (DOA) but those opinions won't stop the discussion and testimonies. A section of the bill discussed today was to CLARIFY THAT THRIFT SAVINGS PLAN DISTRIBUTIONS ARE NOT EXEMPT FROM KANSAS INCOME TAX. Ron and I knew that, but apparently some legislators didn't. One committee member made a caustic comment about state retirees having a "free ride" with their income tax exemption and it's a short jump to bring federal retirees into the conversation. Accordingly, following is some advice offered by Jim Miller as our State legislative Chair:

*"(1) IF you don't know your Representative and Senator, at least become acquainted with their key staffers. (2) Make them understand the importance of retaining the KS income tax*

*exemption LAW in place (3) compile a list of reasons. For example, you might explain that it may affect your decision to continue to live in Kansas, or that you would be looking to move to another state that has the exemption. (Note: Missouri for example now has a more tax friendly environment for feds.) (4) list the many taxes WE do pay on a regular basis (5) list any organizations, church, good causes they support in Kansas, helping to improve the quality of life for Kansans. (6) Pass on help and assistance to others. We have many NARFE members who utilize that tax exemption to pass on to others. Request they send you the lists, as, IF we are given enough time to submit for testimony, Ron Richey and I can use those, should this exemption come before a committee..... Hearing. The key is to stop it in committee. IF it makes it to the floor of the House....my guess is the tax exemption is gone! Then we will have to work to stop it in the Senate."*

Judy Etter, NARFE Area Vice President received the following information from her State representative: "The GOV's tax plan finally came out in writing on Friday. From what I can tell, it did not take the exemption away. BUT, there is a second bill to make your TSP and Railroad retirement taxable! This one seems to be under the radar right now- I've got to get some light on it too! "Based on the above comments, our tax exemption is not under immediate attack; however, we want to be in a position to take action to prevent any changes in the proposal.

The following is an example of language our RVP Carol Ek used to contact her state senator. Hopefully it will help you model something you could use to send to your own state congressional representative and state senator. Many of you who have email addresses registered with NARFE may have received this email from Carol directly. This can be sent by email or by letter.

**SAMPLE LETTER / EMAIL**

*I understand that innuendoes are surfacing to eliminate the Kansas Income LAW tax exemptions for Federal Annuitants living in Kansas.*

*I am one of those retired federal annuitants and would like to give a few reasons why this exemption LAW should stay in place.*

*(1) In Kansas, we have approximately 23,624 active federal employees; and 24,251 (retired federal employees earning approximately \$50,902,000 per month) living; raising their families; and purchasing goods in Kansas.*

*(2) Many federal annuitants presently living in Kansas maintain their main home in Kansas simply for the enjoyment of this tax break and voting privileges. They can pick up at any time moving to another State who will retain this tax privilege.*

*(3) Many federal annuitants and federal employees are middle income tax families, who cannot move because of MEDICARE privileges, doctors who accept MEDICARE, their churches, their families, and the voluntary positions they hold which better the quality of life for all Kansans. Many of these volunteers donate quality time in these venues.*

*(4) By staying in Kansas, these federal employees and spouses retain their homes paying real estate taxes, buy their goods paying Kansas sales taxes, and help maintain their schools, churches and all other benefits enjoyed by all Kansans.*

*(5) To gain this benefit, I spent 40 years of my life working and serving the general population of McPherson County, Kansas, every week day and believed it an honor to one day retire in this beautiful State. I am asking your help in defeating the proposal to take this tax exemption away from this group of people.*

**MESSAGE FROM NARFE PRESIDENT JOSEPH A. **1) NARFE PRESIDENT TESTIFIES BEFORE SENATE SUBCOMMITTEE:** On February 1, NARFE President Joseph A. Beaudoin testified before the Senate Subcommittee on Oversight of Government Management, the Federal Workforce and the District of Columbia

**2) SENATE FLOOR MAY CONSIDER BILL WITH NARFE-OPPOSED FECA PROVISION:** The Senate may take up controversial legislation to overhaul the U.S. Postal Service, S. 1789, as early as the week of February 6. This legislation includes a NARFE-opposed provision to drastically change the Federal Employees' Compensation Act (FECA). NARFE President Joseph A. ### **NARFE CALL CONGRESS DAY PLANNING REMINDER**

Here (again) is the step-by-step process for NARFE's Call Congress Day on **February 15**. President Joseph A. Beaudoin asks each NARFE member to save the date of Wednesday, February 15, and share this step by step plan with all NARFE members via chapter newsletters and other communication channels.

**Step 1:** Call the Capitol using NARFE's toll-free number, 866-220-0044. Ask the operator to connect you to your representative's and/or senators' office.

**Step 2:** Tell the staff person who answers the telephone next where you live, so they know you are a constituent, then say:

- "I am a retired/active federal employee and member of NARFE." [Tell the staff person a little about your work.]
  - "[Senator or Representative X] represents thousands of federal workers and retirees and their survivors. Any plan that pays for two-thirds of the payroll tax holiday by taking money out the pockets of fewer than 2 percent of America's middle class is unacceptable, unfair, and certainly isn't shared sacrifice."
  - "Federal workers, retirees and survivors have already done their part, saving the federal government \$50 billion through a two-year pay freeze. Making \$65 billion in further cuts to pay, earned health and retirement benefits, or making changes to cost-of-living adjustments, would unfairly single out those who protected our nation, including many now on a fixed income."
