HOT TOPICS!

- The Senate will be voting soon on the House passed Budget Resolution (House Concurrent Resolution 34) which includes \$375 billion in savings over ten years from current and retired federal employees. Visit the updated www.ProtectAmericasHeartbeat.org for information.
- John Barry, Director, Office of Personnel Management, stated on May 4th that his highest priority is to find a way to accurately measure employees performance.
- Republicans have proposed saving more than \$120 billion over the next decade by requiring the civilian workforce to contribute more toward retirement — a plan that would effectively impose an immediate 5 percent pay cut on more than 2 million federal employees. President Obama's bipartisan fiscal commission has also endorsed the idea, calling the federal system “out of line” with the private sector.
- On Thursday, May 26th, the House Subcommittee on the Federal Workforce held a hearing titled “Downsizing the Federal Workforce.” Many in Congress pretend dramatically fewer federal employees, paid less, will solve America's fiscal dilemma.

MYTHS AND TRUTHS

Myth: NARFE is focused on Civil Service Retirement System (CSRS) employees and retirees rather than those in the Federal Employees Retirement System (FERS) or other systems.

Truth: NARFE's focus is on everyone in the federal family. Following are examples of NARFE's legislative accomplishments on behalf of everyone in the federal family:

FERS Sick Leave: Permits FERS workers initially to credit half, and in 2014, all of their unused sick leave toward retirement.

FERS Redeposit: Allows returning FERS employees, who previously left federal service, to repay a deposit to the Retirement Trust Fund, with interest, to combine their past and new federal service for future annuity service.

National Security Personnel System: Ends the Department of Defense's pay-for-performance personnel system and restores employees to the federal General Schedule pay system.

Locality Pay Equity: Provides locality pay that is creditable toward retirement for federal employees in Hawaii, Alaska and the U.S. Territories.

Proposals were dropped that would have required federal workers to join health exchanges. That would have opened the Federal Employees Health Benefits Program (FEHBP) to nonfederal civilians without separate risk pools.

Myth: I'll let other NARFE members respond to Congress; my one response will not make a difference anyway.

Truth: NARFE needs everyone's help in fighting the proposed reductions in pay and benefits. But only about one in six NARFE members have provided their e-mail addresses to receive "legislative alerts." Additionally, only half of those used the Legislative Action Center in 2009 to correspond with their senators and representatives. Every member's response is critical. NARFE needs all members to sign up to receive these legislative alerts, and most importantly, to use the NARFE Legislative Action Center to write their senators and representatives.

LEGISLATIVE REPORT

Seems all we get is bad news. Just to name a few:

Civilian federal employees salaries frozen for 2 years.

The House passed a bill which would reduce spending by \$4.4 trillion over ten years, of which \$375 billion would come from current and federal retired employees. This bill would also require:

1. FERS and CSRS covered employees to contribute substantially more to their retirement.
2. Freezing federal pay for 5 years.
3. Reduce Federal workforce by 10% over 3 years.

At the time of this writing the Senate has not voted on this bill.

Also there is talk to require employees and retirees to pay a larger percentage in federal health premiums.

Obviously, NARFE members must follow National NARFE's lead and contact Senators Roberts and Moran and Congresswoman Jenkins as well as President Obama in opposing action detrimental to our benefits. This makes it very important for all who have computer Internet access to receive the latest from NARFE headquarters. Those who haven't, please do so by joining GEMS (Global Electronic Messaging System) at www.narfe.org select GEMS, enter member ID # (on your NARFE magazine label) complete and submit. You will receive Legislative Hotlines and other messages. GEMS is the best way to stay informed and assist in protecting earned benefits.

The 2011 Kansas Legislation adjourned May 13. Federal retirees were untouched, thus retaining the Kansas Income Tax exemption on CSRS and FERS annuities. Jim Miller and Ron Richey, Topeka Chapter have spent countless hours at the State house monitoring hearings and protecting our interests. Some of our Chapter members have volunteered and will help them when requested.
