He will be talking to us about legislative issues that have an impact on active and retired federal employees at the national level.

From the President:

I attended the CONK meeting in South Sioux City, NE on August 29-31. It was an informative meeting and copies of many of the presentations are available through the NARFE website or by calling me for a copy. Four of the National NARFE officers from Headquarters were present. They shared that the main objective during the budget deficit debate is "WE AS FEDERAL ACTIVE AND RETIRED EMPLOYEES DO NOT WANT TO BE SINGLED OUT FOR CUTS!!!" The Protect America's Heartbeat effort has been effective and the number of calls, letters and e-mails seem to have made a difference in awareness of the position of NARFE members. There is more information in the NARFE magazine. NARFE-PAC report indicated that PAC does not buy votes as we do not have that volume of members or dollars but the donations do help allow access to candidates supportive of Federal Employees issues for both active and retired. Come to the October meeting to learn more about legislative efforts on behalf of NARFE. Alzheimer's Research chair wanted to make sure that we know that 100 percent of funds that NARFE members contribute goes strictly to research. To date, NARFE has funded a total of 49 scientists.

First Amendment to the U.S. Constitution

The Constitution was written by the Constitutional Convention in 1787 and was thereupon transmitted to the Continental Congress. In 1789 the proposed amendments were sent to the states because a number of states wanted further declaratory and restrictive clauses added in order to prevent misconstruction or abuse of powers by the government. Ten of the 12 were adopted and they became the Bill of Rights upon ratification in 1791.

The First Amendment is known as the freedom of religion and freedom of speech amendment: *“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”*

It was natural to have this amendment first because of the Christian faith-based principles upon which America was founded such as:

The first act of the Continental Congress in 1774 was to pass a motion to pause for prayer; and the prayer was based on Psalm 35;

General George Washington set days of prayer and fasting for his soldiers and directed the Continental Army commanding officers to procure Chaplains for their regiments;

The 1776 Declaration of Independence recognizes that God is the Creator and source of liberty; and

In 1783 the Treaty of Paris that ended the Revolutionary War began with these words: “In the name of the most holy and undivided Trinity”

This prime spot on the Bill of Rights indicates that the founders believed that freedom of religion and freedom of speech were of utmost importance when the Bill of Rights was ratified.

From the Legislative Chair:

On August 2 the federal government increased our \$14.3 trillion debt by \$2.4 trillion dollars. A “Congressional Joint Select Committee on Deficit Reduction,” also known as the “Super Committee” of 12 Senate and House members was created to try to agree on where to cut spending \$1.5 trillion over 10 years. It also took the responsibility off the Senate and House to deal with the out-of-control federal government spending!

Some of those 12 members will want to raise taxes to keep growing government while others will want to start cutting government back and stop increasing the debt.

By November 23rd we will learn what this Super Committee accomplished. The Senate and House are supposed to vote on it by December 23rd. Even if Committee members come to an agreement the President can veto it if it is not to his liking.

The government will stop taxing our children, grandchildren, and great grandchildren to pay off the debt when we get House and Senate members and a President to stop borrowing money. We borrow 40 to 45 cents of every dollar the federal government now spends. We cannot continue down this path.

The NARFE Legislative Director says that “NARFE supports efforts to balance the budget and reduce the national debt....”

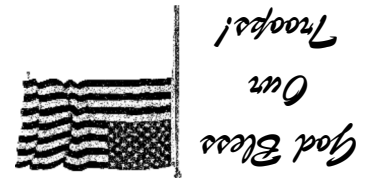
