After being "saddle sore" from sitting on a hard wooden chair in a Committee to Simplify Kansas Taxes meeting at the State House, on Friday, November 12, I should type this standing up? Sometimes what Ron Richey, Ron Neis and I do for NARFE members isn't as "romantic" as it may sound, especially during the out of session meetings. They are necessary, and sometimes informative. And if Ron Richey and I were paid at minimum wage, and we're not, today would have cost NARFE about \$100.00 plus meals. With that, I'll go to Dues increases.

Our chapter has operated near deficit for several years, and if we hadn't had a great group of Chapter 0002 members pitching in to hold a very successful NARFE state convention last April, frankly, we would have "gone broke". So, for several years, we've waited for national to increase and change the dues structure, before we proposed a CHAPTER dues increase.

A national dues only was approved at the recent national convention. Our executive committee brought a Chapter Dues Increase of about a nickel a week to the last chapter meeting. That dues increase, from \$ 8.40 to \$ 10.80 a year will be voted on at our December 3 luncheon meeting. The increase won't upgrade our operation but will allow our valued Treasurer, Sherry Potter, to pay the bills on time. There will be discussion, and \$10.80 is the bare bones figure. Some members suggested that be raised, to

avoid having to increase dues again in a comparatively short time.

So, call me @ 478-0651 to make your reservation for lunch, \$ 12.00 per person, and voice your opinion.

Two positive voices defending public service employees (city, local, state, federal) and retirees have published reports of their studies in response to the slanted editorials in the Wall Street Journal and USA TODAY. Those editorials were picked up by local newspapers across the nation, including the Topeka daily, and blasted the pay and benefits of active workers as well as retirees.

The new studies show (1) current public service employees are NOT paid far more than private sector employees, and retirees who enjoy higher annuities or pensions paid far more than private sector retirees.

My thoughts, it's about time we fought back, but we have to wonder, why go after us in the first place? I'll see you on December 3!

Pam Maxwell BC/BS – Pam reviewed some of the rules and regulations of the Affordable Car Act recently signed into law and how it will affect FEP effective 1/11/2011. She also reviewed the new service plan brochure that will be mailed to all current members on November 9th. New premiums will be:

Basic Option – Single increase of \$12.61 per month to \$113.27 Family increase of \$29.51 per month to \$265.49

Standard Option - Single increase of \$12.10 per month to \$187.18 Family increase of \$30.63 per month to \$431.60

Note: The government pays 70% of the total premium.
