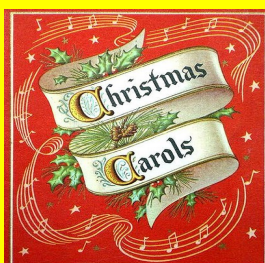

One of the worst mistakes federal employees can make is failing to have five years of Health Benefits Program (FEHBP) coverage before retiring, and the other is if you have a spouse or family and do not have self + one, or family Health Benefits Program (FEHBP) coverage. If a federal employee dies and family members are not already covered they will not be eligible to participate in the Health Benefits Program (FEHBP) if they are not already a participant.

If you are satisfied with your current health plan, you do not need to do anything. It's quick and easy to request health benefit changes and plan information in any of the following ways.

For every NEW member recruited from September 1st through December 31st, the recruiter will receive \$10 AND be eligible for monthly prizes throughout the contest as well. **You will need to put your membership number and your name on the F-135 in order to receive credit for recruiting individuals.**

We will receive a 2% cost living raise for federal retirement annuities, as well as for military retiree annuities and January Social Security payments. Federal employees will appreciate the average 1.9 percent raise.

I attended NARFE – What's happening! in Wichita, KS. **The NARFE web site is going to change next year. You will be required to log in with a secure login. If you have not given NARFE your E-mail, you will need to provide them with one in order to log in. You may contact our Chapter # 2 Secretary to provide an update regarding your personal information.**

The government is funded through December 8, 2017.

The Kansas Supreme Court requested that Kansas lawmakers provide a reasonable strategy for increased funding of K-12 public school districts by June 30, 2018.
