Within the 3rd Congressional District, there are approximately 11,000 active employees and federal retirees, so thus we do represent a substantial number of votes within this district. The next goal we have is to hopefully arrange a similar meeting in the future with Senator Moran's district office.

I hope all of you that have e-mail addresses have provided those to NARFE HQ, or have made sure that the address you have provided is current. This will ensure you receive the weekly GEMS messages enabling you to respond when HQ requests prompt action to contact our congressional delegation. I know I have stressed this before. However, it is the best way to reach many of you in a timely manner with critical, time sensitive information. You can also get the weekly hotline messages by calling the toll free number listed on the back page of this newsletter, or by going to the NARFE website, which has undergone some great improvements. Also, our excellent chapter website has links to the NARFE website, along with other important chapter information.

For those of you who haven't been at our recent chapter meetings, there are several items to update you on. The chapter board members all agreed that we want to put more emphasis in recruiting new members, as it truly with greater numbers that we have more clout with Congress. So for this year, as an incentive for you to recruit new members, the board agreed that we would on a quarterly basis, reward anyone who recruits a new chapter member with \$5.00. So we hope this incentive will give you even more reason to help us gain new members.
