## AUTOS AND NARFE

When you look at this picture of an early assembly line, it conjures up thoughts of America's automotive past or today's news of industry giants GM and Ford now laying off thousands of workers, closing plants, debt ridden, an uncertain future. But there is another message that comes to mind as you look closely.

It's a classic photograph - one of action, teamwork, completing an objective, no frivolous activity. There's no one standing idly by watching others work. They have a single purpose. It's building a car; whereas, we are supposed to be building up membership to increase our political clout.

## THE INTERNET AND CHAPTER 1162

The workers in the picture changed with new technology, and we have a subtle change in our chapter membership due to new technology. For example:

Today, we have 826 chapter members and 14 percent of the members are on the Internet. Three years ago it was about 4 percent. It's probably closer to 20-25 percent because some members do not provide National with their e-mail addresses where we get our information. It appears that we are now about in line with nationwide trends.

The Pew Institute\* in a February 2004 survey found that 22% of Americans age 65 or older reported having access to the Internet. That's up from 15% in 2000. By contrast with the 65 or older group, 58% of Americans age 50-64, 75% of 30-49 year-olds, and 77% of 18-29 year-olds currently go online. As you read this newsletter, about a quarter of our members could have been reading it on the Internet. You can read it now on the Internet on our Web site at [www.narfe-chapter1162.org](http://www.narfe-chapter1162.org). We are changing.

Wired seniors - the Pew Institute reported - are often as enthusiastic as younger users in the major activities that define online life such as email and the use of search engines to answer a specific question. Communication and information searches attract wired seniors. There has been sharp growth in the number doing key Internet activities such as health searches, e-shopping, and online banking. (It's been a bonanza for genealogy, America's most popular hobby).

NARFE headquarters sends out an e-mail each Friday when Congress is in session to members who have registered their e-mail address. It's a worthwhile Internet service for keeping up with news that affects our retirement and health insurance plans. You can join this news service - called GEMS - by calling headquarters, or you can register on NARFE's Web site ([www.narfe.org](http://www.narfe.org)). If you are already on GEMS and have changed your e-mail address be sure and re-register with NARFE.

## NEW RESOLUTION – ASSOCIATION DUES

The Kansas Federation has proposed a resolution to amend that part of National Bylaws applicable to Membership and Dues.

This resolution is a reincarnation of previous proposals to establish a single national dues fee to fund the three branches of our organization: national, federation and chapter. The Federation proposal falls into this category. Under this single dues proposal "chapter dues," as we know it today, would be eliminated from the dues system. In its place a fixed portion of the dues would be rebated to the chapter.

The national dues fee (it's now called an Association fee) is \$38.00 with \$8.00 rebated to the chapter in the Federation's proposal. A chapter may assess its members an additional amount if \$8.00 is insufficient for their operations.

When you compare the amendments in this proposal against the existing national bylaws and our dues systems with its multiple dues categories, questions arise as to how it will be implemented.

For example, it strikes out the entire section pertaining to current federal employees. Will this group lose its existing multiple dues plan?

## CHAPTER 1162 SHAWNEE MISSION - WHERE DID THE SHAWNEE MISSION COME FROM?

**THE HISTORY.** Shawnee Indians, along with many other eastern tribes, were moved to present-day Kansas in the 1820s and 1830s. Upon relinquishing their lands in the East, Shawnees received a large tract of land (about 1.6 million acres) west of Missouri in an area sometimes called the Great American Desert.

In July of 1830, Chief Fish, a white chief of the Shawnees, requested a missionary through their Indian agent George Vashon. A missionary society was formed in September 1830. Reverend Thomas Johnson (pictured at left), a Methodist minister, was appointed missionary to the Shawnees and his brother William, missionary to the Kansas tribe.



Reverend Thomas Johnson was born in the Shenandoah Valley in Virginia and later moved to Missouri. He married Sarah Davis (pictured on right) at Clarksville, Missouri, in 1830, and that same year he arrived with his new bride in present-day Turner, Wyandotte County, Kansas. Here he established the

first Shawnee Methodist Mission. The school was in operation at that location until 1839, serving the Shawnee and Delaware tribes.

Johnson became dissatisfied with the school's functioning and proposed to the missionary society that a central school be built to serve many tribes. A site was chosen where a branch of the Santa Fe Trail passed through the Shawnee lands.

Building began, and the school opened at the present Johnson County location in October 1839. Indian children of many tribes were sent to this school to learn basic academics, manual arts, and agriculture. Some of the tribes represented were the Kaw (Kansa), Munsee, Delaware, Ottawa, Chippewa, Otoe, Osage, Cherokee, Peoria, Kickapoo, Potawatomi, Wea, Gros Ventres, Omaha, and Wyandot.



State of Kansas acquired it in 1927. Since that time it has been administered by the Kansas State Historical Society.
